

CAMP CROSSFIRE 2012 APPLICATION PACKET



PURPOSE: Camp Crossfire is a Christ-centered youth camp that teenagers attend to learn more about being champions in their life with Christ. The camp will be an intense four-day event including church services, Bible studies, workshops, water games, scavenger hunt, and many other activities. Camp Crossfire will provide an opportunity for teenagers from all over to come together and experience an unforgettable week!

Our desire is not only for the campers to come and have a fun filled week, but for them to grow in their relationship with Christ.

WHO CAN COME?: Anyone who is going into the 7th grade – the completion of 12th grade!

FEE: The cost per camper is \$ 175. This fee includes room, board, camp t-shirt and cap, and entertainment. A \$ 50 deposit, along with application is due by July 13th. Camp is limited to 80 campers and applications will be accepted on a first come first serve basis.

FACILITIES, HOUSING, AND FOOD: Camp Crossfire will be held at New Mexico Junior College (NMJC) in Hobbs, NM. Campers will participate in services at Watson Hall along with the Ben Alexander Student Learning Center with dining hall, tennis, basketball, and volleyball courts will also be available. Campers will be housed on campus in NMJC residence hall. Members of the camp staff will serve as dorm counselors. Meals will be served by the college food services at the Student Center. Cowboy Junction Church will be providing breakfast and the evening meals.

REGISTRATION AND DEPARTURE SCHEDULE: Registration will be Monday morning, July 23rd from 9:00 - 10:00 am at the dorms on the NMJC campus. Departure will follow a celebration service on Thursday, July 26th, at 3:00 p. m. in Watson Hall. Parents, friends, and family are invited!

CAMP REGULATIONS: Campers are not allowed to be off campus unless with an organized and supervised camp group. All campers and parents will be required to sign a no tolerance policy, stating that if any of the rules or expectations are broken then that camper will be sent home.
